

Data protection notice for online applications

The Rensel GmbH & Co. KG constantly observes the currently applicable data protection requirements when processing your personal data ("data") in connection with the performance of our staffing services. Your data are collected, processed, and used in accordance with the relevant provisions on data protection.

In the mandatory fields marked with *, we only collect details which are required to process your application within the frame of the application procedure. In particular, in order to be able to contact you in good time, we need your e-mail address and your telephone number. You have the possibility to enter free text, in order to provide us with information which we can draw on to evaluate your profile.

In addition to the collected contact details, data referring to your professional qualification, application documents including pictures and your placement preferences (which you manually supply us with by using the uploading function) your data might, however, also include so-called special personal data within the meaning of art. 9, para. 1 of the Data Protection Regulation. The collection, processing and usage of these data is carried out for the purpose of your direct placement, direct employment or within the framework of a temporary employment.

Within the scope of the agency relationship, we will collect your data, and we will process and use it for placements or temporary employments in case of suitable offers. This also includes the forwarding of the personal data collected in the context of staffing services to interested enterprises.

In order to be able to offer you as many companies as possible, regardless of location, the affiliated companies of **Rensel GmbH & Co. KG**, which are active in the field of personnel services, are also involved in the placement process, and are given access to your data for this purpose.

In addition, we will not pass on your personal data to third parties; unless we are obliged to do so due to mandatory legal regulations or you determine this yourself. In our case, third parties are not service providers who have to comply with our data protection requirements. For this we have concluded order processing contracts and thereby quarantee that we can exercise your rights.

Moreover, we will store your data for six months. If by that time, no successful direct placement or lease could have been effected, we will contact you and ask you for an extension of the data processing period - i.e., for another six months. Should you fail to respond or not wish any further processing, we will immediately delete your data.

You have the right to receive free information at any time about your personal data stored by us. Furthermore, you may object to the collection, processing, and usage of your data at any time for the future, or to have your data rectified, blocked or erased.
